# Judging times will be provided closer to the trial

The A/B Sections: The Novice A class is for beginners. Those dogs who have earned a title in that element (in AKC or in another organization), and those handlers who have worked as professional detection dog handlers must enter the B section. The exhibitor is fully responsible for entering the dog in the correct class(es)/divisions. Failure to do so will result in the cancellation of qualifying scores.

Move Ups - move-ups will be allowed between Trials 1 & 2. As soon as you finish that element, go to the secretary and fill out the move up form to be in the next level for Trial 2.

# DOG ELIGIBLE TO ENTER

This trial is open to all Welsh Springer Spaniel dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP).

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

### **ENTRY FEES**

\*an entry is defined as a single run by a single dog, in a single class. Entry fees include a \$3.50 per run AKC recording fee.

### WAIT LIST INFORMATION

WSSCA is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 50 entries per day will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to Wednesday – May 15, 2024, at 6:00 pm EDT. No entries may be withdrawn with a refund after closing on Wednesday – May 15, 2024, at 6:00 pm EDT. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

### STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

A warm-up area will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blanks containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run. The warm-up area is not for training or relieving of the dog.

### SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces. in livestock holding areas.

### ADDITIONAL SITE INFORMATION

**Trial Site.** It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

**Possession of Odors and Training.** Chapter 5. Section 26 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Spectators are welcome if the judge permits.

**Indoor Crating** may not available. Entrants should be prepared to crate dogs in their vehicles in the parking lot. Information regarding indoor crating will be sent with the Judging Program.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

# ROSETTES, AWARDS, AND PRIZES

First Place in all classes will receive a dog toy.

A New Title rosette will be awarded to each dog completing a title.

All entered dogs will receive a commemorative item (Limit 1 item per dog).

### High in Trial

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge usually a flat collar, martingale or harness. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash or crated at all times. Retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

### **ENTRIES**

Entries must be made on Official AKC entry forms or copies and <u>must include the signed Agreement and Rules</u>. Junior Handlers must enter their JH# and complete back of form.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee. No refunds will be issued for overpayment of less than \$10.
