

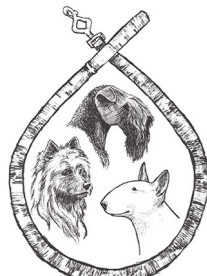

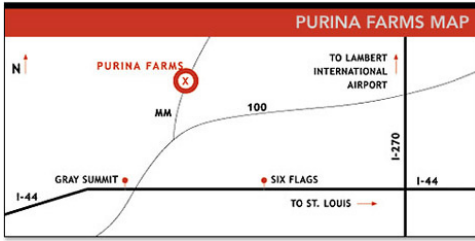

DIRECTIONS TO THE ANIMAL EMERGENCY CLINIC: Take Hwy I-44 East to Big Bend Rd. Turn right on Big Bend. The Emergency Clinic is on the left-hand side.

Non-Regular Classes Involving Multiple Dog Entries

STUD DOG CLASS is for Stud Dogs and two (2) of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the Regular Classes, or if a Champion of Record, in Best of Breed Competition, but must be entered in the Stud Dog Class. The Get must be entered in one of the Regular Classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional classes fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merit of the Get.

BROOD BITCH CLASS same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get where appropriate.

A castrated male may be entered as the Stud Dog in the Stud Dog Class and a spayed bitch may be entered as the Brood Bitch in the Brood Bitch Class.

As the judge's decision in the Stud Dog and Brood Bitch will be based on the merits of more than one dog or bitch, none of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class

Best Puppy

During the course of Regular judging, the assigned judge will select a Best Puppy from the Class winners of the 6 mos and under 9 mos and the 9 mos and under 12 mos. classes. This will be done after the Best of Breed Competition judging unless the Best Puppy award is automatic. **Example:** an entry from the Puppy Classes is awarded Best of Winners or Best of Breed. Only dogs undefeated in a Puppy Class are eligible for Best Puppy Competition. If the first place winner is not present, the second place winner may not compete.

Best Bred-By-Exhibitor

During the course of Regular judging, the assigned judge will elect a Best Bred-by-Exhibitor from the Bred-By-Exhibitor Class winners. This will be done after the Best of Breed Competition on judging unless the Best Bred-By-Exhibitor award is automatic. **Example:** an entry from the Bred-By-Exhibitor Class is awarded Best of Winners or Best of Breed. Only dogs and bitches undefeated in a Bred-By-Exhibitor Class are eligible for the Best Bred-By-Exhibitor Competition. If the first place winner is not present, the second place winner may not compete.

Best Veteran

During the course of Regular judging, the assigned judge will select a Best Veteran from the winners of the Veteran Classes. This will be done after the Best of Breed competition judging unless the Best Veteran award is automatic. **Example:** an entry from the Veteran Class is awarded Best of Breed. Only dogs undefeated in a Veteran Class are eligible for Best Veteran Competition. If the first-place winner is not present, the second-place winner may not compete.

Award of Merit

May be given to two dogs, at the discretion of the judge to outstanding entries in final consideration for Best of Breed. All of those in Best of Breed Competition are eligible except Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch and Best of Winners, as the judge has already found them worthy by virtue of their win.

Award of Merit

Award (s) of Merit may be given at the discretion of the judge to recognize quality dogs and bitches in Best of Breed competition. Award of Merit winners may be selected from the exhibits remaining in competition after Best of Breed, Best of Opposite Sex to Best of Breed, Best of Winners, Select Dog and Select Bitch are chosen. (BOB, BOS, BW, SD and SB are not eligible for the award.) The number of awards which may be given is determined by the number of dogs and bitches exhibited in Best of Breed competition as follows:

6-11 = 1 Award / 12-17 = 2 Awards / 18-23 = 3 Awards / 24-29 = 4 Awards / 30-35 = 5 Awards / 36 or more = 6 Awards.

Each Award of Merit winner will receive a rosette.

The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Retrievers (Nova Scotia Duck Tolling), Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendéen, Whippet, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Australian Cattle Dog, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdog, Spanish Water Dogs, Bassett Fauve de Bretagne (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers., Pulik.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Lagotto Romagnolo, Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terrier, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

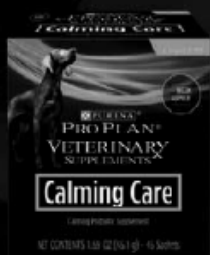
