
Each entrant whose dog passes their assigned track will receive a ribbon and award from the Heartland WSSC.

Test Site:

The test site is the Ottawa Field Trial Grounds, a part of the Kettle Moraine State Forest. There is a State Park entry fee that is the responsibility of each entrant and spectator. The site is on the south-east corner of Wisconsin Highway 67 and County C1, about 9 miles south of the Interstate 94 and Highway 67 interchange. The entrance to the grounds is one-third of a mile south of the 67/C1 intersection on the east side. Drive all the way to the end and park close to the shelter. The draw(s) the day of the test will be at this shelter.

STATE PARK FEE: The daily park entry fee is \$13.00 for Wisconsin residents and \$16.00 for non-residents for which entrants and spectators are responsible. The closest Wisconsin DNR office is:

Directions: North on Highway 67 5.3 miles from the site entrance to the intersection with US18. Left on US18 approx. 1/2 mile to Main Street. Left (South) on Main Street to the intersection of Main Street and Wilson Ave. The clinic is on the SW corner.

ENTRIES: The entry fee for the TD test is \$80.00 and for the TDX \$140.00. This includes the AKC recording and event fees. Checks should be made payable to the Heartland WSSC. Please do not send entries by any method requiring a signature for delivery. Mail entries to the Test Secretary: Hans Muessig, 1611 Quie Lane, Northfield, Minnesota 55057. You will be notified by email upon receipt of your entry. Entries must be on the official AKC entry form. *NOTES:* A certification statement must accompany each TD entry of a non-titled dog. Dogs must have a TD or TDU title to enter the TDX test. An exhibitor may enter more than one dog.

ENTRY DRAWING: Thursday April 17, 2025, at 7:30 pm local time at 1611 Quie Lane, Northfield, Minnesota, 55057 to determine which dogs will participate. The public may observe; please contact the secretary prior to attending. Entries for this test will be accepted up to the official closing date, even though the advertised limit has been reached. TD entries *must* be accompanied by a certificate. The drawing shall be completely random among all Welsh Springer Spaniel entries received for each test. If the advertised limit has not been drawn for each test, a second drawing will be held for the remaining (other breed) entries until the advertised limit has been reached. Any remaining entries shall be assigned a position on an alternate list corresponding to the order in which they are drawn. Preference in the TD test will be given to dogs who have not earned a TD; preference in the TDX test will be given to those dogs who have not earned a TDX. If the limit for entries is not reached in one test, and the limit is exceeded in the other test, the number of tracks will be exchanged up to the limits set by the event per AKC Tracking Regulations (Chapter 1, sec. 17a). The Test Secretary will notify each participant by phone and the alternates by email. Entry identification, a judging program, and directions to the test site will be sent to each entrant and alternate. In the event an entrant cancels or is absent on the day of the test, the Test Secretary will contact alternates in the order of the drawing. Upon notification, the alternate will have the option of accepting or refusing entry. If for any reason a dog making the draw is not present or cannot run the day of the test, their fees will be refunded provided an alternate competes in their place.

TEST HOURS: Friday May 2, 2025, 6:00 am to 5:00 pm. The drawing for TD track order will be held at 7:00 am at the Trial Grounds shelter. The first TD track will be run as soon as ready following the draw. The drawing for the TDX tracks will be at 9:15 am and the first TDX track run as soon as it is ready.

BITCHES IN SEASON may participate in accordance to Chapter 2, sec. 8 of the AKC Tracking Regulations. The handler must notify the Test Secretary prior to the drawing for track order on the day of the test.

RISK: The owner or agent entering a dog in this test does so at his/her own risk and agrees to abide by all of the Rules and Regulations of the American Kennel Club. The Welsh Springer Spaniel Club of America and the Heartland WSSC assume no responsibility for any personal property, theft, injury, or death of an animal or damage to any property while at this test, or in transit to or from the site.

DISASTER AND EMERGENCY PREPAREDNESS PLAN: The Heartland WSSC has prepared a plan for this event and it will be available at the test site on the day of the test.

ACCOMMODATIONS: The location of the tracking test is approximately 25 miles east of the WSSCA Nationals show site in Jefferson and the hotels at Johnson Creek. Hotels in Oconomowoc and Delafield are closer (due north) of the tracking site at Wisconsin Hwy 67 and Interstate 94 or slightly east.

SPECTATORS AND VISITORS are welcomed, encouraged, and expected. WSSCA members value the camaraderie and good sportsmanship that is inherent in the sport of tracking! As such, we expect exhibitors, members of the gallery, and all involved in this test to display such behavior. We will not tolerate foul or abusive language, mistreatment of a dog, or disrespect of the judges, test committee members, exhibitors, tracklayers, or members of the gallery. Any display of these behaviors can and will be reported to the AKC. These offenses are subject to fine and/or suspension by the AKC.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
